PUBLIC PARTICIPATION FORUM ON DIGITIZATION OF CITIZEN SERVICES

The government of Kenya has embarked on a plan to digitize at least 5000 government services with a view to enhancing government service delivery. The government has also embarked on the development and installation of an end-to-end Civil Registration and Vital Statistics System capable of generating and assigning a Unique Personal Identifier (UPI) at birth, which will act as a lifetime identity for new-borns.

Given the foregoing, and in the spirit of consultative governance, the State Departments has scheduled a public participation forum with relevant stakeholders to share the Government's roadmap to the digitisation of services.
